LEGAL AID ACT 1971

LEGAL AID (FEES AND CONTRIBUTIONS) (AMENDMENT) REGULATIONS 2023

IN exercise of the powers conferred by subsection 32(1) of the Legal Aid Act 1971 [*Act 26*], the Minister makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Legal Aid (Fees and Contributions) (Amendment) Regulations 2023**.

(2) These Regulations come into operation on 1 May 2023.
